

OFFICIAL CALL
Mass Meeting of the King George Republican Committee
of the Republican Party of Virginia

As Chairman of the King George Republican Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Larry B Kile, do hereby issue this call for a Mass Meeting to be held at King George County Citizens Center, 8076 Kings Highway, King George, VA 22485, starting at 7:00pm local time on March 23, 2010, for the following purposes:

1. Electing a Unit Chairman of the King George Republican Committee.
2. Electing members of the Unit Committee as follows:
 - a. At Large – 7 Members
 - b. Courthouse Precinct – 11 Members
 - c. Passapatanzy Precinct – 6 Members
 - d. Monroe Precinct – 21 Members
 - e. Dahlgren Precinct – 10 Members
 - f. Shiloh Precinct – 12 Members
3. Electing up to 95 Delegates and an equal number of Alternates to cast 19 votes at the 1st Congressional District Convention, to be held on May 15, 2010 at Caroline County High School, 19155 Rogers Clark Blvd. Milford, VA 22514, (or its alternate site) beginning at 1:00pm, Delegate registration opens at 11:00am., for the following purposes:
 - a. Electing a District Chairman;
 - b. Any other business as may properly come before the Convention.Each unit is entitled to one (1) Delegate Vote per 500 Republican votes for Governor and President at their last election, so that the King George Republican Committee is entitled to 19 Delegate Votes.
4. Any other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of King George County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party after March 1, 2004, or in the last five years, whichever is more recent.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of this exception thereafter.

Voters may be required to produce personal identification such as a valid drivers license or voter registration card.

Registration Fee

There will be no registration fee required to participate in this mass meeting, but a voluntary contribution of \$10 per participant is requested. There is a voluntary registration fee of \$10 for the District Convention.

Mass Meeting Registration

Registration for the Mass Meeting will begin no sooner than 5:45pm local time and end no earlier than 6:45pm local time. Registration time may be extended at the direction of the Chairman. All persons in line at 6:45pm local time will be allowed to register.

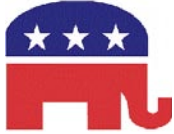
Candidate Pre-File Requirements

All candidates for Unit Chairman, Committee Member and/or 1st Congressional District Convention Delegate are required to pre-file their intentions by completely and properly submitting the 2010-2012 Declaration of Candidacy application indicating the position(s) being sought by mail, to the King George Republican Committee, Post Office Box 221, King George, VA 22485, which MUST be received not later than 5:00pm local time Wednesday, March 17, 2010. Post-marks do not govern. Applications will also be accepted in person at all properly called meetings of the King George Republican Committee prior to March 17, 2010. The County committee has imposed a \$100.00 Candidate filing fee for Chairman. Candidates for King George Republican Committee Membership may submit a voluntary two year membership fee of \$50 along with the application. Only those who properly pre-file for Unit Chairman can be nominated at the Mass Meeting for Unit Chairman. Only those who properly pre-file for Unit Committee Member can be nominated at the Mass Meeting for Unit Committee Member. Only those who properly pre-file for 1st Congressional District Convention Delegate can be nominated at the Mass Meeting for 1st Congressional District Convention Delegate. No candidates for Unit Chairman, Unit Committee Member or 1st Congressional District Convention Delegate may be nominated from the floor. The County committee has imposed a \$100.00 Candidate filing fee for Chairman. Candidates for King George Republican Committee Members may submit \$50 for the two year membership dues in the King George Republican Committee along with the application. Only those who properly pre-file for Unit Chairman / Unit Committee Member can be nominated at the Mass Meeting for Unit Chairman / Unit Committee Member. No candidates for Unit Chairman or Unit Committee Member may be nominated from the floor.
